

DARE TO DREAM

Dear Friends,

Can we dare to dream of a world where cancer is no longer feared? Where it's a disease that has a cure? Where the majority are survivors and not victims. Yes, we can. The Indian Cancer Society with renewed vigour and zeal is striving to turn this dream into a reality.

As India's most respected NGO in the cancer space for the past 65 years, we play an active role in creating awareness and encouraging early detection among the masses. Facilitating cure, rehabilitation for the underprivileged patients and offering support to survivors has always been our area of focus.

It is time now to scale up our activities, set new goals for 2020. A national footprint should see us manning 100 mobile detection vans throughout the country creating cancer awareness through films developed on key cancers in the regional languages and providing early detection at your doorstep. The youth of our country must lead the change of mindset towards this dreaded disease through social media and events. Raising Rs. 100 crores annually for disbursement through the Cancer Cure Fund will make the life-saving treatment available to many of those who simply cannot afford it.

To this end, in the past one year, we have produced 4 films in 7 languages raising awareness and encouraging early detection. Students, young professionals and matinee idol - Varun Dhawan - have been enrolled to be part of our mission. CSR funding has enabled us to add a new state-of-the-art mobile medical unit detection van, currently under fabrication, to increase our reach in the rural areas.

To further increase the impact of our Cancer Cure Fund, in collaboration with HDFC AMC, we have 13 hospitals to our empanelled list across India. Since its establishment in 2011 we have sanctioned 56.97 crores, to fund the treatment of 2216 patients. We have now nearly quadrupled our disbursements with the enhanced new fund and CSR support from HDFC. In fact, this dimension of the ICS success story has evoked a Harvard Business School case study. A special paper on the fund was presented at the last World Cancer Congress held in Australia, in December 2014, by our Medical Director, Dr Purvish Parikh. ICS has also reorganized its operating structure by identifying 4 core areas – Awareness & Screening, Cancer Cure, Cancer Registry responsible for research and knowledge, and Rehabilitation and Survivorship, which includes the Ugam – support group of childhood cancer survivors.

Integrated planning and execution with our Branches is the key to help realize this dream. Towards this end, the 3rd edition of "ICS ONE" held in March 2017, helped amalgamate all our efforts into one single tide.

The need of the hour is to come together from all walks of life, pool in our resources to battle this disease and emerge victorious. We seek active support and assistance from individual donors, trusts, the corporate world, medical fraternity, hospitals, the government, health ministry, well-wishers, stakeholders and all related NGOs to help scale-up our activities.

The next 5 years will help ICS take the giant leap to realize this dream.

Indian Cancer Society was established in 1951 by Dr. D.J. Jussawalla and Mr. Naval Tata as India's first voluntary, non-profit, National Organization for Awareness, Detection, Cure and Survivorship of those affected with this disease.

Indian Cancer Society has been doing sterling work in fighting cancer across India. It has been and continues to be the beacon of hope for thousands of our poor cancer affected brethren. The extent of help required is phenomenal. Most of the patients come to us from all over the country and can't afford two meals a day. In such cases undergoing treatment is beyond their capacity. The society is entirely dependent on public support for its various activities concerned with financing the treatment and rehabilitation of cancer patients and for spreading the cancer awareness and its early detection.

Activities

- Creating nationwide awareness of cancer, its risk factors, preventive measures, treatment options, survivorship, and encouraging regular checkups as cancer can be cured if detected early.
- Providing for the early detection of cancer through cancer screening centers and mobile cancer detection camps across India, especially for the underprivileged.
- Providing funds for the treatment of cancer for poor cancer patients across India
- Providing support during and after treatment to poor cancer patients through accommodation, rehabilitation, and survivor support groups.
- Gathering and collating data through the population based cancer registry for Mumbai, Pune,
 Nagpur and Aurangabad (ICS is the only NGO to run a cancer registry), and providing analytic and projected reports on the incidence of cancer.
- Providing a medium for the dissemination of information and research findings to the medical fraternity through the Indian Journal of Cancer.

CANCER AWARENESS

Our mission: To create awareness that cancer is preventable and curable

Indian Cancer Society conducts cancer awareness camps in school, colleges, corporate offices, slum and rural areas on a pan India level.

At these camps, a trained ICS representative presents short films and a talk on various cancers like cervical, breast, oral and lung. The films explain what is cancer and its causes, symptoms and the lifestyle changes required to protect oneself against cancer. These camps are conducted free or at a minimal cost.


Breast Cancer Awareness campaign

Relay For Life comprises of an opening ceremony, followed by the survivors lap, the Luminaria ceremony and the closing ceremony. The emotionally charged luminaria ceremony remembers those lost to cancer.

CANCER SCREENING

Our mission: To facilitate the early detection of cancer

Indian Cancer Society strongly believes that "Cancer is curable, when detected early." Awareness followed by early detection improves the chances of battling this dreaded disease. Early diagnosis of cancer has been the core objective of our Mobile Cancer Screening Camps and the Cancer Screening Centre at Peddar Road, Mumbai.

In 1982, Indian Cancer Society launched its first Mobile Cancer Screening to provide people with easy access to cancer checkup facilities free or at a nominal cost. It has since extended larger.

Our mission: To offer emotional support and medical aid to cancer patients

Cancer Cure Fund

Cancer Cure Fund (CCF) is the flagship project of Indian Cancer Society which provides financial aid for treatment of underprivileged cancer patients. Many cancers are curable, if detected early and treated in time. However, in India most patients with cancer are not able to afford the treatment costs and therefore do not survive the disease. This project provides financial aid up to ₹ 4 lakhs each for treatment support. CCF has transformed lives of over 2500 such patients across the country, many of whom have completed their treatment and returned to a productive life. ICS has implemented this at a pan India level covering 26 states. We are pleased to report that 80% of the beneficiaries are less than 30 years of age, which means more birthdays to be celebrated!

CCF was initiated in February 2011 as a joint initiative with HDFC AMC, where in a close-ended capital protection oriented income scheme called 'HDFC Debt Fund for Cancer Cure' was launched. This scheme provided the investors an option to donate 50% or 100% of their dividend income to ICS to provide financial assistance to underprivileged cancer patients for their treatment.


In FY 2015-16, CCF received donations aggregating to Rs. 6.39 crores from over 2500 investors.





Dr. Arun Kurkure Initiation and Treatment Fund

Everyday hundreds of poor patients come to Tata Memorial Hospital (Mumbai) from across the country because they may be suffering from Cancer. Often they come with nothing as many come from underprivileged backgrounds. The financial numbers that they hear towards the cost of initial diagnosis scares them to return home without doing the tests. In a study done by just the pediatric department at TMH showed that the dropout rate was 20%.

To overcome this, Indian Cancer Society introduced Dr. Arun Kurkure Initiation and Treatment Fund. This fund aims to help patients who are unable to afford the initial costs of diagnosis and/or need help in covering certain part of their treatment costs. Any patient from a government hospital can take benefit of this fund. For diagnosis, an immediate payment of Rs. 15,000/- is made to their account in the hospital to enable the treatment to start. For those who require aid for treatment, Rs. 10,000/- is provided.

Sir Ratan Tata Trust (SRTT)

In December 2009, Sir Ratan Tata Trust magnanimously offered to assist Indian Cancer Society in its efforts of providing financial aid to underprivileged cancer patients undergoing treatment at the Tata Memorial Hospital & the Bai Jerbai Wadia Hospital.

Under this project, Indian Cancer Society along with SRTT, funds part or the entire treatment costs of 7 patients each month. The applications are thoroughly scrutinized by Indian Cancer Society's medical social workers in accordance with the strict guidelines laid down by SRTT and then sent to SRTT for evaluation and acceptance.

Meet few of our patients...



Paritosh Mahuri

A sole bread-winner for a family of three in Agartala, Tripura, Paritosh Muhuri was diagnosed with cancer in 2002. He had an annual income of Rs 42,000 through private tuitions. He started getting severe joint pain and fever and was devastated when diagnosis at the GB hospital in Agartala confirmed that he was suffering from Acute Myeloid Luekemia, a kind of blood cancer.

Paritosh was referred to Tata Memorial Hospital, Mumbai for treatment in August 2013 after his condition worsened and he started to complain of throat pain and

bleeding. He was asked to undergo Bone Marrow Transplant (BMT) in October that year, as it was the only way to save his life.

With the cost of treatment estimated at Rs. 12, 00,000, Paritosh was resigned to his fate as he had spent all his life savings on his treatment in the past decade and had even sold his land. He was referred to ICS-CCF by the hospital's Social Service Department. After detailed analysis of his case, ICS-CCF sanctioned Rs. 4 lakhs for his treatment in July 2014 and the BMT was completed within six months. After completion of his treatment, Paritosh has started giving private tuitions. His daughter is now 5 years old and the doting father has thanked ICS-CCF for the support and helping him start his life afresh.



Pankaj Kumar

Son of a farm labourer in Bulandsheher, UP, Pankaj's life was turned upside down when he was diagnosed with Osteogenic Sarcoma. Just 20, Pankaj was preparing for entrance tests to join the Army. A freak accident, while dancing at a friend's wedding, resulted in a minor fracture which led to Osteogenic Sarcoma, a type of bone cancer. Complaining of severe pain in his leg, Pankaj was referred to Dharmshila Cancer Hospital in Delhi where it was confirmed that he was suffering with bone cancer and the doctors recommended amputation of his leg so that the cancer would not spread. He then went to Rajiv Gandhi Cancer Institute (RGCI), New Delhi for a second opinion.

At RGCI, the doctors also recommended surgery to amputate the leg and then would provide him with prosthesis. The entire treatment cost was approximately Rs. 5.5 lakhs and it was not possible for his parents to arrange for the money. He was referred to ICS - CCF in August 2012 and was sanctioned Rs. 4 lakhs. The surgery was done and he was fitted with prosthesis. Pankaj has also completed his education and is a commerce graduate. He is now working as a Computer Operator in BSNL, on a salary of Rs. 9,000/- per month. On 10th March, 2016 he got married and still continues his passion of bike riding. He is deeply grateful to ICS - CCF for valuable assistance and giving him a ray of hope to be able to live his life.

REHABILITATION CENTRE

Our mission: "It's just not enough to add years of life, it is equally important to give quality of life to the added years".

The ICS Rehabilitation Centre houses workshops where patients are given vocational training according to their individual needs. They are taught mat making, tailoring, bag making and printing. For those undergoing treatment, this helps to ease their mental tension due to prolonged treatment for cancer and make a livelihood during this period.

PROSTHETIC & ORTHOTIC AIDS DEPARTMENT

The unique aspect of the Prosthetic section lies in the fact that all aids and appliances are produced by cancer victors. Different types of breast prosthesis, cervical cancer kits, jaw stretcher keys, limb prosthesis and colostomy sets are made at this one of a kind workshop and are sold to patients all over the country at a nominal cost. They are provided free of cost to the underprivileged.

SELF RELIANT SURVIVOR PROJECT supported by GSK

Our mission: To help the families to become self reliant

Cancer patients come to Mumbai from all over the country for treatment at TMH. For many of them it is a life of hardship with no place to stay and no means of sustenance. The Self Reliant Survivor Project of ICS supported by GSK helps such families to live with dignity and to learn a new skill for earning a livelihood.

Patients or their dependents are trained in tailoring for up to six months. This enables them to return to their villages with a new source of income for the family. During the training they are provided a daily stipend, meals, reimbursement of accommodation and travel expenses, food supplements and rations for the month. The biggest gain is to be able to live with dignity while

the patient is under treatment and to learn a new skill.





Trends of All Sites in Mumbai Cancer Registry for both the sexes (AAR)









Trends of All Sites in Pune Cancer registry for both the sexes (AAR)









Trends of All Sites in Aurangabad Cancer Registry for both the sexes (AAR)





INDIAN JOURNAL OF CANCER

The Indian Journal of Cancer, the first indexed oncology journal from India, was established in 1963. It is still the foremost periodical, serving the needs of all the specialties of oncology in India. Its international repute is recognized by its indexing with most bibliographic databases including MEDLINE, Index Medicus, EMBASE and Biological Abstracts. The journal is the official publication of the Indian Cancer Society, the Indian Society of Oncology (ISO) and the Indian Cooperative Oncology Network (ICON).

The authorship as well as the readership of Indian Journal of Cancer has expanded beyond the boundaries of the country. Annually more than 5000 copies of the journal are distributed. Apart from journal's own website, the internet issue of the journal attracts more than 5000 visitors per month from all over the world. The journal utilizes most advanced tools for its management including an electronic system for manuscript submission and review.

Ugam is a voluntary support group of childhood cancer survivors formed in June 2009. It is a unit of Indian Cancer Society, functioning under its survivorship program. The 230 childhood cancer survivors who are registered with Ugam were treated at Tata Memorial Hospital. Ugam is expanding its wings to include childhood cancer survivors from all the pediatric cancer units in Mumbai.

Ugam means "To Rise" underscoring their determination to rise above all obstacles in life and be victors.

Activities of Ugam

Educational Support

Ugam supports the education of these by providing ICS education scholarship and refers deserving candidate's applications to scholarships provided by others NGOs.

Awareness and Fund Raising

- During various ICS events, Ugam members perform activities spreading the message about curability of childhood cancer.
- Ugam members participate and support in the various fundraising events of ICS including various events like Dahihandi, Race of Hope, Mumbai Marathon, and Relay for Life and various other events held at ICS.

Counselling

Ugam organizes counseling sessions for parents of children with cancer at Tata Memorial Hospital
and St Jude's Child care centers which gives hope to the active patients. They also counsel other
childhood cancer survivors attending ACT Clinic on every Tuesday at TMH.

Prashanti is the wellness unit of Indian Cancer Society. Prashanti helps in mainstreaming cancer survivors back to normal living by offering yoga, laughter therapy and reflexology. For women who have undergone mastectomy, Prashanti offers breast rehab clinic by providing and fitting women with bras and body forms at no cost. We provide two bras and one body form for every woman who has undergone a mastectomy.

Major events organized by ICS - Delhi

World No Tobacco Day – This event was held on 17th April at Navy Children School. The format
was a skit competition, poster making and a debate competition. The topic was "Importance of

plain packaging" and was showcased by the students with great assertiveness. The event was held at DPS Sushant Lok and 17 schools participated.

- 2. **Annual seminar** Cancer Sahyog organised their annual seminar on 16th October at PHD Chambers. The topic of discussion was 'Cancer Looming threats and perils of wilful ignorance'.
- 3. **Rise against Cancer** is Indian Cancer Society's community connect activity, targeting an audience within a community, where people of all walks of life come together and awareness is spread through screening, talks, competitions and raising money. Three events were held in three different venues where schools, RWAs, came together and awareness was spread through walks, nukkad nataks, poster competitions, interactive workshops and preventive screening initiatives.
- 4. **Survivors' day** Silver Jubilee 'Celebration of life' was the theme that was carried to the heart of the capital on Cancer Sahyog completing its 25 years of existence. The venue was Rajiv Chowk. The event consisted of dances, group dances, medley of old hindi songs, walking the ramp by survivors accompanied by their doctors from various hospitals, light bollywood music.
- 5. **Concert of Hope** the annual ICS fundraiser was held on 6th March at the amphitheatre of India Habitat Centre. The band Advaita performed and brought the house down. Mr Suhel Seth, long time contributor to ICS was the chief guest.

BANGALORE BRANCH
