

MISSION INDIAN CANCER SOCIETY

For nearly 70 years Indian Cancer Society (ICS) has been a beacon of hope in the fight against Cancer, a disease which is now taking serious proportions in India. Over 12 lakh new cases are reported every year, many being identified at late stages leading to poor survival rates. While better treatment and more facilities are an obvious solution, the well known adage "Prevention is better than Cure" is very much applicable here. ICS is increasing its focus on prevention aspects by improving people's understanding of cancer, advising on risk and signs if any. ICS is educating public on preventive steps like screening, which can be done very simply for 3 common cancers; Oral, Breast & Cerrvical. Interestingly these constitute 1 in 3 cases in India!

What do we do?

Awareness: The current understanding of cancer i.e. its treatability, preventability and how to deal with it is abysmally poor in our country. With the help of mass media and direct communication, ICS aims to raise basic understanding of the disease, such that in time the entire adult population will know what to do for prevention and how to get support for those affected with the disease. We also wish to promote low cost Cancer Insurance Schemes in alleviating financial distress of the weaker sections of society, in the eventuality of cancer affliction.

Screening: Screening is a way to identify suspect cases. ICS's mission is to enhance population based screening of the 3 most common cancers, to encourage every adult to go for it. Clearly this monumental goal can only be achieved with involvement of multiple stakeholders; NGOs, public health centres, health care agencies, Doctors and Hospitals across the country. ICS will champion this by enrolling various Stakeholders and training NGO Teams where necessary. Our mission is to raise so much awareness amongst people, wide and deep, such that in time people voluntarily go for screening.

Cancer Cure: ICS plays a very modest role in supporting treatment of some underprivileged patients in our empanelled hospitals across the country. So far, 7200 patients have been supported. While this may largely be a role for the Government, that it is now doing through Ayushman Bharat and other Central and State programs, for others not eligible for these, the cost of treatment can be crippling. Sometimes the financial support obtained by the needy is insufficient and we help bridge the gap. Also because of high demand, often the poor are not able to access treatment. Our plan is to increase impact by scaling up by using technology based methods. We also want to widening the footprint with partnerships and replication of models.

Survivorship & Rehabilitation: With increasing incidence and higher survival due to better access and care, the number of pediatric and young survivors is also increasing. Unfortunately, despite surviving the disease, often they are unable to get back to normal life i.e. unable to get proper education, social acceptance, employment, addressing of late effects of treatment because of lack of resources. It is important to not only save people with cure but give them a helping hand to bring them into the mainstream. That's what we attempt in this vertical.

Medical: We publish the prestigious "Indian Journal of Cancer" and manage registries in Maharashtra. Scientific symposiums are held for the medical fraternity on cancer incidence, mortality and trends in Greater



Mumbai, Pune, Nagpur and Aurangabad registries. Our desire is to build these areas and get into participative research.

TRANSFORMATION WITHIN & PARTNERSHIPS BEYOND

The last twelve months have been a watershed era for ICS leapfrogging into the NEXT level, in terms of a wide range of activities and donor support.

We have identified key strategic guidelines:-

- a) Continuously improve our quality.
- b) Expand footprint of our activities exponentially, with good partners and collaborators.
- c) Develop contemporary modules for improved impact and delivery.
- d) Share learning and expertise with other NGOs and become truly an apex NGO in the Cancer space.

Some outcomes of recent times -

- Improved relationship with TMH leading to new potential collaborations.
- 2. New Relationship with National Cancer Grid and Non Communicable Diseases Cell.
- Strengthened National Management Committee with eminent Oncologists.
- 4. Closer engagement amongst branches.
- 5. Widened donor portfolio.
- 6. Sharp increase in visibility of ICS through mass media, PR, social media and brand collaboration. This year we started the Mass Media Awareness campaign at National level with Dainik Bhaskar newspapers and BIG FM in Feb Mar 2019 and reached an estimated 20 million audience. Subsequently, in the following months Film, TV and Social media campaigns have been launched building up to an estimated 50 million people.
- 7. Dramatic increase in screening activity, going beyond Maharashtra.
- 8. Multiple increases in number of patients supported financially for treatment in the last three years.
- 9. Significant enhancement in survivorship activity and public visibility.
- 10. This has been possible with re-organisation, better staffing and motivated teams.

CANCER SCREENING

Screening for early detection of cancer

Screening refers to the use of simple tests done for a healthy population in order to identify individuals who may have cancer, but do not show symptoms. Screening can be done for breast cancer, cervical cancer, and oral cancer using Breast Clinical exam / Mammography, Cytology screening, and Oral visual inspection for a wide coverage of the population. Early detection of cancer greatly increases the chances for successful treatment.

ICS conducts screening in the community and through the years has partnered with various community organisations, NGO's, and corporations. The objective is to reach out mainly to the underprivileged who do not have access to such medical facilities and also the general population.

Since last year, we have collaborated with Tata Trust to screen high risk persons such as bus drivers, conductors, and workshop staff from Maharashtra State Road Transport Corporation and BEST for Oral cancer.

We have also partnered with Astra Zeneca for the "Ganga to Kaveri Cancer Screening Project" to conduct Screening and Awareness for Breast, Cervical and Oral cancer for women in Maharashtra, Karnataka and Tamil Nadu. This programme will cover other states in the next phase.

BEST and MSRTC Projects

TATA Trust funded BEST project was started in April 2018 and MSRTC Project was started in November 2018 for screening of oral cancer for employees of BEST and MSRTC. Indian Cancer Society has planned to conduct oral cancer screening in both men and women and breast cancer screening in women with the MSRTC employees over a period of two years.

Over the phase of one year we have reached employees in 19 districts covering 20,534 beneficiaries. 3022 suspect cases have been identified and referred for further evaluation.

This project has the dual objective of creating awareness and screening of oral, cervical and breast cancer for women in India. The general screening will be conducted for women from 30 - 69 years and mammography for those over 45 in Maharashtra, Karnataka and Tamil Nadu.

Cancer Awareness created with the right information is the key to cancer prevention, early detection and prompt decision making about treatment. More than 35% of cancers can be prevented by leading a healthy and active lifestyle, abstaining from tobacco and alcohol and undergoing regular screening for the most common cancers.

Doctors often say that they would rather prevent cancer, than have to diagnose, treat and cure it, because they could then save the patient of all the pain, distress and huge cost of treatment.

Creating Cancer Awareness in the population has been a core function of ICS since inception. Cancer rates in the country are rising to alarming numbers, so we have decided to take this message to the people through mass media campaigns for greater impact and wider reach. Along with this, the regular awareness programmes in the community are also being conducted.

WORLD NO TOBACCO DAY

World No Tobacco Day was observed by creating awareness about the harmful effects of Tobacco through a Radio campaign on 93.5 Red FM from 29th May with the message - "Shuruvat toh karo". On 31st May, India's No. 1 RJ Malishka appealed to the listeners to quit tobacco and tobacco related products.





On the occasion of World No Tobacco Day, flash mobs performances were done in theatres to spread awareness from May 31 to June 1. This was conducted at three theatres - Mukta A2 cinema, New Excelsior at Fort and Topiwala at Goregaon.

The audience enjoyed the performance which gave the message of "Quit Smoking" through songs and pamphlets with health messages and importance of tobacco cessation were distributed.







To sensitize the common man on hazardous effects of tobacco, ICS organized Nukkad Natak at ten different places across Mumbai (particularly in the slum areas). Many people were interested and gathered around to see the group of artists conveying the all important message about the dangers of Tobacco through the street play performances.





On the eve of WNTD, ICS held a drawing competition for students of Gurukul School of Art, Curry Road with the theme – Anti Tobacco.

This was a creative way of sensitizing the children in the age group of 8 - 15 years about Tobacco. The children actively participated in the competition and expressed their thoughts through their paintings. All participants were given Certificates and pamphlets with health messages and importance of tobacco cessation.








On the occasion of Breast Cancer Awareness month, an article about Breast Cancer written by Dr Sewanti Limaye, was published in the New Woman magazine.



Subsequently more awareness Advertorials have been published in newspapers about Cancer Screening, Cancer Cure and Cancer Insurance. More Advertorials will be published on topics of Breast Cancer Cervical Cancer, Oral Cancer, Main streaming of Cancer Survivors etc.









The Indian Cancer Society - Cancer Cure Fund (ICS-CCF) is a major programme of the Indian Cancer Society. The fund provides financial aid for treatment of underprivileged and low income patients diagnosed with any treatable cancer through empanelled hospitals in different parts of the country.

Indian Cancer Society-Cancer Cure Fund provides need based assistance up to Rs 5 lakhs each to cancer patients with an annual family income of less than Rs 4 lakhs. Over the last 8 years, the ICS-CCF has been a source of support and hope to more than 7200 patients across the country. These patients have received Rs 112 crores for their treatment; many of whom have completed their treatment and returned to productive lives. Of these, over 60 per cent are less than 45 years of age, which means a more fruitful life ahead and more birthdays to celebrate!

Birth of the Cancer Cure Fund

In 2009, Dr Arun Kurkure, Nihal Kaviratne and Hari Mundra, trustees of the Society, wanted to evolve an innovative idea of raising funds that would provide certainty of funding year after year for treatment of under privileged cancer patients.


Dr Arun Kurkure wrote a mail to Hari Mundra and Smita Aggarwal on 5th Oct 2009.

"We need to move quickly, as this is a fantastic idea. As a medical person, I have promoted this idea in theory. Since we know that it is an actionable idea, what we need now is a business model. It will be great to make a formal announcement on Founders' Day".

A brainstorming session was held with Fund Managers and Private Wealth Managers on Jan 15, 2010 to launch a co-branded scheme with an existing reputed fund house with the explicit stated purpose that part of the returns generated from that fund would be donated to ICS to provide financial assistance for supporting the treatment of poor patients. HDFC AMC came up with the best proposal.

- ICS was responsible for utilization of donations, oversight and reporting

Key success factors

- 1. HDFC AMC brand, distribution, client relationships were instrumental in acquiring investors and raising funds
- Exemplary governance structure comprising of a Governing Advisory Council (GAC) at ICS, Due Diligence Team (DDT)of expert Oncologists and carefully selected empanelled hospitals.
- 3. Meticulous systems and processes for selection, eligibility and follow up of patients.
- 4. Pro-active role of TMH doctors in steering the due diligence process
- 5. Administrative costs kept at less than 5% year on year.





So far, three series of the CCF have been launched.

The first series raised Rs 12.77 crores and the third series raised Rs 56.75 crores. The second and third series were matched by contributions from HDFC - AMC under CSR. CCF disbursed Rs 64 lakhs in 2011-12 – this rose several fold to Rs 28.54 crores in 2018-19.

The fourth series is expected to be launched in 2020.

Key Highlights of the Cancer Cure Fund


- Individual patient applications are evaluated through a four step process
 - 1st step: Screening by the empanelled hospital 2nd step: CCF team ensuring completeness and accuracy in the documents submitted
 - 3rdstep: Medical evaluation of the application by ICS Due Diligence Team comprising of leading Oncologists
 - 4thstep: Final sanction by ICS-CCF Governing Advisory Council comprising of leading finance, corporate and medical professionals
- Disbursement of funds is made to the hospital in the name of individual patients
- Post-disbursement regular follow-up is maintained with the hospital and the patient
- Concessional rates have been agreed upon with the empanelled hospitals for all patients funded by ICS-CCF
- Detailed evaluation of the costs, processes and competence is carried out before empanelling the hospital
- Annual audit is carried out by statutory auditor on use of funds

Since its inception, other than HDFC AMC, CCF has been supported by institutional donors like SBI Foundation, Union Bank of India, Roche India,

Tata Capital, Dainik Bhaskar, Oriental Bank of Commerce as also individual donors.

In FY 2018-19, CCF received donations aggregating to Rs 13.96 crores from over 5000 HDFC AMC investors and HDFC AMC has further contributed Rs 14.96 crores under CSR. The total donation in FY 2018-19 was Rs 30.97 crores from all sources.

Another unique aspect of the CCF program is that it is implemented pan India. Apart from the high cost of treatment, families of cancer patients undergo severe stress as they have to usually draw down their savings, sell their assets and borrow money, to be able to travel to the place where the hospital is located and stay there till the treatment is over. The CCF is conceived to provide treatment close to the place of residence of the patient while ensuring that the hospital provides the standard of care needed.








Cancer Cure Fund Annual Conference 2019

A conference was organized for Oncologists and Medical Social Workers from the CCF empanelled hospitals on 18th March 2019. DDT doctors, ICS trustees and staff also attended. The focus was on Saving Lives.

An outcome study presented by Dr Tushar Vora (Associate Professor -Department of Medical Oncology –Tata Memorial Hospital) showed that the survivorship results of all patients who had completed 5 years treatment met the 50 per cent curability criteria laid down in the Scheme.

The medical social workers were informed about the importance of follow up of patients and their role in ensuring that the patients do not abandon their treatment.

The strategy to collaborate with empanelled hospitals on awareness, screening and survivorship was also part of the agenda and was well received.

The evening program was organized in collaboration with Tata Memorial Hospital at NCPA, Nariman Point where the play "Monsters in the Dark" adapted from Dr Siddhartha Mukherjee's, Pultizer prize-winning book – "The Emperor of All Maladies" was performed by artistes of Bangalore Little Theatre.





CCF Case Studies

Nidhi Baipotu, 9, diagnosed with Ewings Sarcoma in Dec 2016, is from Vishakhapatnam, AP. Nidhi's mother says that the pain in her daughter's thigh started when she was 6 years old and she was shattered when told that her leg could not be saved. Nidhi had been diagnosed with Ewings Sarcoma she was supported for treatment through ICS – CCF at Tata Memorial Hospital, Mumbai.

Her mother's concern was "my daughter is handicapped; how will she go through life?" But she was determined to make her daughter succeed in spite of the disadvantage and wants her to be a role model for others.

Nidhi participated in The World Children's Winners Games in 2019, which are International sports competitions for survivors of childhood cancer. She won Golds in Chess, Running and Swimming and a Bronze in shooting! We are very proud of this little 9 year old champion!

CCF Case Studies

Bhavnaben Singh, 8, diagnosed with ALL in June 2016, hails from Chaibasa, Bihar. Bhavna started getting constant fever and became so weak that she would be out of breath after walking for short distances. Her parents took her to Kailash Cancer Hospital, Goraj, Vadodra for treatment when she was diagnosed with ALL. Her mother was

distressed and wished that she should die rather than see her little child go through pain and stress during the treatment. Her father is full of gratitude to ICS – CCF and says that her life is saved because of the funds they received. Bhavna has completed the treatment, goes to school and wants to be an engineer!





Mohd Azaz, 34, was diagnosed with Seminoma in Dec 2017.

Mohd Azaz is an Arabic teacher from Bangalore. He was devastated when he was diagnosed with Seminoma. Everyone told him that it was the end of life as nobody can survive cancer. He was demoralized as he had no one to support him

emotionally or financially. He was referred to ICS – CCF for funds and says "My misconceptions were removed when I saw that I received all help without any bias or discrimination, as if I was a brother or son".

He has completed the short 4 month treatment required for this cancer at Sri Shankara Hospital, Bangalore and is back at work.







Dr Arun Kurkure Initiation and Treatment Fund (AKITF)

Many poor patients come to the empanelled hospitals, but return home as they have no money for the diagnostic tests. They come back when the cancer is in an advanced stage, the treatment difficult and the chances of survival are low.

A study done by the TMH showed that the dropout rate in such cases was as high as 20 per cent.

Dr Arun Kurkure Initiation and Treatment Fund supports such patients for their diagnostic tests and also their first emergency treatment, without any loss of time, giving them the best opportunity for recovery from cancer.

This fund was re-launched on 4 February 2019 in two of the CCF empanelled hospitals; BKL Walawalkar Hospital, Chiplun, Maharashtra and Cachar Cancer Hospital, Silchar, Assam.

Laxmi Vaidya, 52, had heavy bleeding for one month when she was referred to the Hospital for further evaluation. When she was informed about the cost of investigation and treatment she was ready to stop the tests mid-way as she could not afford the costs. Before she left, she met the doctor and shared her financial concerns. The doctor registered her case under AKITF and she was supported for the investigation tests and initial treatment. She was diagnosed with Ca Cervix for which she under went Chemotherapy. She is responding well to the treatment. She says that there are many people like her who are unaware about this scheme and do not report for the investigations once they find out the cost. Hence, she has decided to help other people who need this assistance by informing them about the scheme.

Lala Nunia, Ghungoor Kuarpar Cachar Cancer Hospital, Assam

37 year old Lala is a father of three, an auto rickshaw driver who provides for his family by driving a rented vehicle. He registered with Cachar Hospital because of his health issues and disappeared after he found out the costs of the initial investigations. Follow up calls to get him back for diagnosis brought no results. Since he is the sole earning member he was not ready to compromise his livelihood at the stake of his family, but his health was failing. He came back to the hospital and with the support of Arun Kurkure Initiation & Treatment Fundhe underwent the initial evaluation and was diagnosed with Non Hodgkin's Lymphoma. He is now being treated through the Assam State Scheme and now understands that "there is surely a solution to every problem, one has to look for it."





SURVIVORSHIP

Cancer survivorship is an important component of care across the cancer continuum. The transition of a cancer patient from active phase of treatment to survivorship phase needs to be smooth and proactive. Cancer survivors receive high quality care during the active phase of treatment. However, it is not the same during transition to a passive survivorship phase. In India, survivorship issues are not channelized through structured survivorship programs.

The holistic model of cancer survivorship program taking care of medical & psycho-social needs of survivors, is well exemplified for childhood cancer survivors. The model has evolved through the After Completion of Therapy (ACT) clinic at Tata Memorial Hospital and Ugam, the childhood cancer survivors support group at Indian Cancer Society.

Taking inspiration from this experience, ICS launched project PICASSO (Partnership in Cancer Survivorship Optimization) in 2016 to take this initiative to pediatric cancer units in other major hospitals. The aim is to facilitate the partner institutes to start a hospital based ACT (After Completion of Therapy) Clinic for holistic (Medical & Psycho-social) care of survivors to standardize survivorship care in an already established ACT Clinic within the hospital for medical follow up of survivors. ICS helps to implement the psycho-social module following a needs assessment.

In 2018-19 ICS has partnered with Wadia, KEM & Sion Hospitals in Mumbai and Rajiv Gandhi Cancer Centre in Delhi.

Dr D J Jussawalla Education and Vocational Skills Fund

Indian Cancer Society is making efforts to develop educational and rehabilitation programs for optimizing Quality of Life of cancer survivors and bringing them into the mainstream of society.

Improving the quality of life of cancer survivors remains a challenge in the mainstream. Dr D J Jussawalla

Education and Vocational skills fund fills this gap and acts as an important project of the survivorship interventions. The primary aim of this fund is to provide financial support for childhood cancer survivors and help them to continue their education. This corresponding year a sum of Rs 22,34,292 has been disbursed to 125 beneficiaries across India.

I was diagnosed with osteosarcoma of left tibia at 10 years of age. After 1 year of treatment at Tata Memorial Hospital I was fully cured. Although my cancer treatment was very painful, I never lost hope, because I knew I will definitely win over cancer, and hence I decided to become a doctor... so that I can serve other cancer patients. In 2015, I cleared the AIPMT exam. I am 21 years old and pursuing final year MBBS at Seth GS Medical College, Mumbai. I am thankful to Indian Cancer Society for providing me holistic care which includes financial and emotional support in education and other aspects of life – Ritesh Kumar

The uniqueness lies in the holistic approach,

wherein support for continuing education is accompanied by repetitive periodic counseling and career guidance. Through this process, survivors self-confidence is gradually boosted and it paves way for autonomous decision-making. The ICS survivorship team hand holds the survivors in times of need to guide them towards the direction of success.

UGAM

The cure rate for childhood cancer has improved with techno-medical innovations. The challenge remains in improving the quality of life of cancer victors. The vulnerability and risk factors associated with post treatment, alienation experienced with peers at school, fear of recurrence etc affects everyday living.

I was diagnosed with Wilms tumour at 5 years of age. I completed my MSC. Chemistry in 2014. I got 21 months industrial experience in R & D and 1 year teaching experience as a chemistry lecturer. In 2017, got married, cleared ICT PET exam... Currently I m pursuing PHD from Mumbai University... my dream is to become a R&D scientist. I am thankful to ICS, UGAM, friends and family who supported and motivated me to achieve my dreams – Indumati Dineshkumar Yadav



SURVIVORSHIP

In 2009, UGAM the voluntary support group of childhood cancer survivors from Tata Memorial Hospital's After Completion of Therapy was formed to meet the psycho-social needs of the survivors. On the last Sunday of every month, UGAM members come together at ICS to discuss and share various happening in their lives. UGAM members also attend the parent support group meetings held at partner hospitals and at St Jude's India Childcare Center, for parental counselling. Ugam is now expanding its wings to involve survivors from ACT clinics of other hospitals as well.

REHABILITATION

In 1961, Asia's first rehabilitation center was established in ICS. In 1979, ICS conducted Asia's first rehabilitation and vocational training workshop for cancer patients.

Our rehabilitation centre is founded on holistic vision of rehabilitation. We currently provide psychosocial rehabilitation that includes activities designed to help the cancer patient build strength and endurance, regain independence, reduce stress and maintain the energy to participate in daily activities. The social worker at ICS provides counselling services to all old and new patients enrolled in the rehab program. The vocational training workshop provides opportunity to learn a new skill and return back to their respective places with income generating livelihood opportunities. The rehab space provides a great sense of psychosocial support to patients, survivors or dependants equally.

The rehab program is further strengthened through Physical restoration services. The prosthesis unit produces breast prosthesis, cervical cancer kits and colostomy sets which are sold at a nominal cost to patients all over the country. They are provided free of cost to the underprivileged. Other skill development activities such as tailoring, bag making not only helps physical restoration but also helps in skill building exercises.

Nutrition and financial support is also provided as a support through provision of daily mid-day meal, nutritional supplements, and stipends to patients, survivors and dependents engaged in rehab activities.

Vocational Units and its Achievements

Prosthetic Unit

The unique aspect of the prosthetic section lies in the fact that all aids and appliances are produced by cancer survivors. These survivors also realize and understand the needs of the patients seeking these services, making it a more a value oriented service to patients. This year the department has produced and supplied prosthetic appliances worth Rs 14,67,925. We have reached more than 2000 cancer patients seeking prosthetic aids and various hospitals across the country.

Bag-Making Unit

The bag making unit produced various types of bags, sari holders, yoga mats etc. Rehabilitation Centre has utilized many opportunities to showcase our products in exhibitions organized by various groups, well-wishers, and organizations. Our rehab unit beneficiaries and ICS team feels proud about the continuing demand for the products produced by the bag-making section. This section has generated Rs 6,46,188 through sale of products manufactured at the workshops.

Tailoring Unit

The project mission is to help the families become self reliant. Through this program survivors from places such as rural Maharashtra, Jharkhand, West Bengal, Uttar Pradesh etc are facilitated to live with dignity and an environment of hope. Often for many of these patients coming to tertiary hospitals for cancer treatment, it is a life of hardship with no



place to stay and no means of sustenance. This projects helps such families to live with dignity, hope and self care.

Through this project, 75 beneficiaries have been benefitted. The beneficiaries consist of mostly patients and survivors and some of them who are dependents. The beneficiaries are trained in batches over a six month period, with a standard tailoring course curriculum. This enables them to return to their villages with a new source of income for the family. There were 31 beneficiaries who received tailoring machines at the end of course completion.

Other Rehab Units

Many of the printing supplies essential for ICS activities is made by the printing unit. They generated a revenue of Rs. 55,380 through various products made for parties outside ICS. Similarly, the welfare unit houses a canteen facility, and staff support services for administrative activities. They have generated an income of Rs. 26,250 through various services offered. These units have been of great value in conducting several of ICS activities.

Outcomes

The efforts of ICS to reach out the marginalised through the rehab unit has been possible through cancer patients. This year our prosthetic section has reached a large number of cancer patients through their production and sale of prosthetics and aids to various individuals and hospitals.






Distribution of Cancer Male & Female 2016









The journal is the official publication of Indian Cancer Society and the Indian Society of Oncology.

Its international repute is recognized by its indexing with most bibliographic databases including Pubmed, MEDLINE, Index Medicus, EMBASE and Biological Abstracts. RELAY FOR LIFE

At Relay For Life events, communities come together to honor cancer survivors, remember loved ones lost and fight back against a disease that has taken too many lives. The funds raised truly make a difference in the fight against cancer. Each year, more than 4 million people in over 20 countries raise much-needed funds and raise awareness through the Relay for Life movement.

Relay For Life teams take turns walking or running around a track at a school, park or ground. Because cancer never sleeps, each team is asked to have at least one participant on the track at all times. Food, games and activities provide entertainment and build camaraderie in a friendly environment.

Dhirubhai Ambani International School, BKC conducted Relay For Life on January 19, 2018. The opening ceremony started with an inspiring speech by a cancer patient, Mrs Jayasree Ramesh, mother of a student at the school. The Relay started with a survivors lap and others also joined in, with breaks for snacks and to participate in activities like ring toss, a quiz about cancer and a video game tournament. The event concluded with a luminaria making workshop, which were then arranged in the form of HOPE, as a tribute to cancer patients and survivors.

RBK International Academy, Chembur held Relay For Life on Feb 8, 2018. It was an overnight event with 150 students participating. It was conducted with great commitment and enthusiasm of students and teachers and hands on involvement of the principal, Ms Monica Sarang. As part of the "Give back" the students conducted an Awareness talk about Dangers of Tobacco for their school staff. Ugam members spoke about their cancer journey and played a friendly cricket match with the students.

American Cancer Society Project - 'All of Me'

The year-long ICS/ACS project focused on enhancing awareness and motivating young working women of the lower and middle income group to seek regular health check-up and screening for breast and cervical cancer to enable timely action if required. A comprehensive long-term Monitoring & Evaluation, 5-6 months after the initial launch of awareness intervention has been done to assess its impact.

Mobile App - M-shakti

The mobile app M-shakti was developed as an innovative IEC tool to disseminate awareness regarding breast and cervical cancer. This is the first app in India redefining the communication around cancer awareness. The App is available in both English and Hindi, with an optional voice assistance feature.

Awareness Talks and Screening

More than 100 awareness talks sensitizing over 7000 people from all walks of life and 14,000 screenings were undertaken. New initiatives in reaching out to Schools and Mohalla Clinics have taken the program to new heights.



CSR Support to Preventive Screening

CSR is accessed under the relevant article of the CSR Act which provides assistance for Preventive Screening. Therefore, CSR has enabled us to

increase the number of sponsored camps, and the number of patients screened during the year.

Mohalla clinics - ICS has initiated screening at Mohalla Clinics and have started screening at the Polyclinics serving a cluster of smaller clinics. An Awareness talk to sensitize the clinic Doctors at Paschim Vihar Polyclinic was held on 21 February. The talk was given by Mrs Jyotsna Govil and Mr R R Mishra.

Visits to Tihar Jail for awareness talks and screening have also been undertaken.



Vrindavan outreach project – The Oureach Project grew from the realization of great need of Awareness in small towns. The Project got off the ground in July 2018 with due diligence visits, Train the Trainer workshop, Screening Camps etc. The aim is to create a local cadre to take over the task of Awareness.

ICS Connect - The EMR (Electronic medical record) system underwent an upgrade with SanSys setting up an independent server on the Office premises. The ICS-Connect program has got a boost whereby data is uploaded directly from the camp site.

The E-Learning program took off with a technical tie up with Khalsa College, DU and a Sponsor. Project E-learning is to spread awareness about cancer to the general population of the country. The Basic Course addresses housewives, students and others who just want to know about Cancer. The Intermediate Course addresses ASHA workers, Auxiliary Nurse Midwives and

others with a basic understanding. The Final level is planned as an interactive coverage with Doctors, which will be taken up at a later stage.

We are happy to report that the Intermediate level Course has been accepted by GoI/AICTE for its Swayam platform increasing its coverage across India.

Central Repository of Screening Data - A natural result of the seminar on AI was the idea of setting up a Central Repository of Screening data from all Branches that will build an Indian Cancer Society Network with required infrastructure to grow into an all-India Data bank. This would lay a foundation for future growth and standardize data storage in a single format. The Project is being designed to store all data in a Central Repository which will be multitenanted by all Indian Cancer Society locations.

Cancer Sahyog volunteers visit 14 different Hospitals and offer Emotional and Financial Support to those in need. The Medical Assistance Committee does a splendid job in examining the requirements and meeting the needs of the patients. Apollo Tyres Foundation Medical Assistance Grant was completed this year.

The ABC Global Charter has been developed to address the most urgent and actionable gaps in treatment and care of patients with advanced breast cancer (ABC) to ultimately improve and extend their lives.

ICS Cancer Sahyog Annual Seminar was held on 22nd September 2018 at the India International Centre. Internationally recognized speakers Dr Shalini Govil,



Dr Anna Roy, Mr Rajesh Kuppuswamy, Prof Gagandeep Kang and Prof Ravi Mehrotra spoke on the subject of "Artificial Intelligence in Healthcare (Oncology)".

Cancer Survivors Day was a fun filled display of high energy. It was held at Select City Walk.

Cancer Care India (CACI) conference - Mrs Jyotsna Govil, presented Cancer Sahyog's activities at the conference held from 7 - 9 December at Art of Living Ashram, Bangalore under the patronage of His Holiness Sri Sri Ravi Shankar. She made a presentation on "BEST PRACTICE IS NEXT PRACTICE", speaking about new initiatives undertaken in the past year.

Initiatives at Prashanti (Healing Center)

It is heartening to see support come in for the Child Care and Rehab Center – Prashanti from its neighbors. Sponsorship for the prosthesis and bras from External Affairs Spouses' Association Charitable Trust (EASACT) and others has enabled more women to avail of the service. Over 900 women who underwent mastectomy were given prosthesis and bras, free of cost.



The Child Nutrition program got a shot in the arm with generous active support of Abbot India and the Essel Social Welfare Foundation. The HPS Trust also helps to provide nutritious food to the children. Psychosocial Support is given to parents who accompany their cancer afflicted children, by Amisha, the ACT psychologist since September 2018.



UICC World Cancer Congress - ICS team attended and participated at the WCC held at Kuala Lumpur from 1-4 October 2018.

The theme was - "Strengthen. Inspire. Deliver"

Social Audits of ICS Work - The ISO Certification has been renewed giving us further credibility in our work. We are also accredited by Credibility Alliance. Social Audit is also being undertaken by the AIIMS Community Health Department conducted at our request. This is the first Social Audit of an NGO.

TCS 10K Run - May 13, 2018 – Close to 100 employees of Beckman Coulter ran in support of the Cancer cause, for the third year in a row.


A Bellyful of Paradise - A Fund Raiser comedy play was performed in November - December 2018. Bangalore
